### **MINUTES REGULAR MEETING Monday, August 18, 2008**

#### **QUORUM**

At 7:00 p.m. on Monday, August 18, 2008, in the City Council Chambers of City Hall with a quorum being present, the meeting was called to order by Mayor George Gaulrapp.

#### **RECORD**

Present on roll call were Council members Klemm, Boldt, Bush, DeVine, Endress, Helms, O'Neill and Corbin (8). Also present were Richard Hauser as Corporation Counsel and city department heads.

#### **PLEDGE OF ALLEGIANCE**

At this time, the Pledge of Allegiance was led by Alderman Klemm.

#### **APPROVAL OF THE AGENDA**

Mayor George Gaulrapp explained item #15 would be removed from the agenda. Alderman Helms motioned for approval of the agenda as presented, seconded by Alderwoman O'Neill. Motion passed by voice vote without dissent.

#### **PRESENTATIONS**

With leave of council there were two presentations tonight. Tom Tyke presented information on the Provena Ice Cream Social on August 24, 2008. Mr. Jim Rhyne of the Boys and Girls Club gave a presentation on the summer youth program. Two counselors, Molly Neary and Homero Nava, spoke to the council about their experience working with the youth.

**COMMUNICATION TO COUNCIL**

At the last council meeting it was asked what the outstanding balance is for the City Lights loan. The Finance Department reported as of July 31, 2008, the balance due on the loan is \$107,000. This loan is with US Bank and the debt service is paid by the Downtown TIF Fund. The final payment on the loan will be in January 2022. There is another loan with US Bank which is paid from the Downtown TIF Fund. This loan is for curb and gutter and the balance due on this loan is \$58,000. The final payment on this loan will also be in January 2022.

**ORDINANCES –THIRD READING**

**3<sup>RD</sup> READING OF ORDINANCE #2008-48:**

**An Ordinance Extending Ordinances 2003-55 and 2003-80 Regarding Chapter 891 (Simplified Municipal Telecommunications Tax) For One Year** – The first reading of this ordinance was held on July 21, 2008. A motion to approve was given by Alderman Klemm, seconded by Alderman Endress. The second reading of this ordinance was held on August 4, 2008 and it was automatically laid over to tonight’s meeting. Upon the third reading of this ordinance, Alderman Corbin stated that he had been contacted by County Board President John Blum requesting that the City exclude all County Government from the taxes. Duane Price of the Finance Department stated that he thought the City was taxed also and there was not a way to excluded somebody, but he would have to check with the Department of Revenue. A motion was made by Alderwoman O’Neill to layover the ordinance until the next regularly scheduled meeting, seconded by Alderman Bush. Motion passed by voice vote 7-1, with Alderman Klemm voting nay.

**3<sup>RD</sup> READING OF ORDINANCE #2008-49:**

**An Ordinance Amending Chapter 480, Section 480.12 (Prohibited Parking Streets) of the Codified Ordinances of the City of Freeport** – Bus Parking at schools. The first reading of this ordinance was held on July 21, 2008. A motion to approve was given by Alderman Endress, seconded by Alderman Helms. A second reading of this ordinance was held on August 4, 2008 and it was automatically laid over to tonight’s meeting.

**Ordinance for Variation, Permit or Amendment of Codified Ordinances of Freeport, Illinois – application by Lynn Allen for property at 802-806 South Adams Avenue for rezoning from R5 (Two Family Residence) to B2-2 (Limited Service Business) -** This ordinance recommended to City Council by unanimous approval by the Planning Commission at their meeting on July 9, 2008. Additionally, there were no objectors filed for this ordinance. The first reading of this ordinance was held on July 21, 2008. A motion to concur with the recommendation of the Planning Commission was given by Alderman Corbin, seconded by Alderwoman O’Neill. Additionally, there were no objectors filed for this ordinance. The first reading of this ordinance was held on July 21, 2008. A motion to concur with the recommendation of the Planning Commission was given by Alderman Klemm, seconded by Alderman Endress. A motion to approve was given by Alderman Klemm, seconded Alderman Endress and it was automatically laid over to tonight’s meeting. The Senior Center had not had a chance to review the agreement. A motion to lay over the resolution to the next meeting was made by Alderman Boldt, seconded by Alderman Klemm. Motion passed by voice vote without dissent.

**Water and Sewer**

Water & Sewer Project Director Denise Ihrig gave council an update on Harlem Avenue sanitary sewer.

**Police**

Chief of Police Jerry Whitmore stated participants had completed the 2<sup>nd</sup> annual Junior Police Academy.

**Fire**

Fire Chief Kevin Countryman thanked all those who had donated to the back-to-school backpacks. He also stated the new ambulance rates have been posted which are based off a Medicare increase.

**MAYOR'S REPORT**

Mayor Gaulrapp spoke about the upcoming Sesquicentennial Celebration.

**NEW BUSINESS**

Each council member was given an opportunity to publicly address significant items of interest.

In addition, City Clerk Meg Zuravel stated beginning with the next council meeting on September 2, the City Council Meetings will start at 6:00 pm as passed by ordinance and published in the newspaper.

**PUBLIC COMMENTS - AGENDA OR NON- AGENDA ITEMS**

Reverend Charles Threadgill, 605 S. Ordway, spoke to council about the potholes on Pleasant Avenue between Galena and Chicago Street. Mayor Gaulrapp stated he would notify Street Superintendent Tom Dole. Rev. Threadgill also added that he was against the passage of Ordinance 2008-53, amending permitted hours of sale for class A liquor license holders.
